### CALCASA awarded over \$750,000 in funding for 3 multi-year projects

**SACRAMENTO, CA** – The California Coalition Against Sexual Assault (CALCASA) is proud to announce that it has been awarded \$752,750 in total funding for three new, multi-year projects: **California Immigration Legal Assistance Project (CILAP)**, a grant from Office on Violence Against Women (OVW) Legal Assistance for Victims Grant Program; **Building Refuge for Immigration Detainees through Governance and Engagement (BRIDGE)**, a cooperative agreement from OVW; and **Cybertech**, a cooperative agreement from OVW. All grants are designed to better support survivors of sexual assault, addressing the unique needs of victim populations in California, and with Cybertech, across the nation.

**CILAP** will allow CALCASA to work collaboratively with partners to address current gaps in access to legal services for immigrant, Limited English Proficient (LEP), and farmworker victims of rape/sexual assault in three remote rural communities in central California. CALCASA will act as the project lead and work in partnership with fellow CILAP recipients including: National Immigrant Women’s Advocacy Project (“NIWAP,” a program with American University, Washington College of Law); Lideres Campesinas (“Lideres” is a program serving farmworker women throughout California); Monarch Services/Servicios Monarca (“Monarch” is a local sexual assault program in Santa Cruz County); Community Action Partnership of Madera County, Inc. (“Madera” is a local sexual assault program in Madera County, CA); the law firms Crowell & Moring, LLP and Morgan Lewis & Bockius, LLP; American Gateways; Victim Rights Law Center; and Sergeant Inspector Antonio Flores (San Francisco Police Department).

As part of **BRIDGE**, CALCASA will work in partnership with Sure Helpline Crisis Center (El Centro), Alliance Against Family Violence & Sexual Assault (Bakersfield), San Bernardino Sexual Assault Services, Inc and three Immigration Detention Facilities to support and meet the critical needs of incarcerated survivors of sexual assault. **BRIDGE** advances CALCASA’s current work with Just Detention International (JDI) on Prison Rape Elimination Act (PREA) compliance, building and enhancing partnerships between CALCASA’s member rape crisis centers (RCCs) and state prisons and youth detention facilities in California.

Lastly, CALCASA has also partnered with Break the Cycle on **Cybertech** which will provide training and technical assistance for criminal justice professionals on the use/misuse of technology in sexual assault, domestic violence, dating violence and stalking (including cyber stalking) cases as a national project.
